## Website privacy policy

This Privacy Policy of Personal Data (hereinafter referred to as the Policy) applies to all information about the User posted on the Internet website at [www.lhi.global](http://www.lhi.global) (hereinafter referred to as the Website), accessible to Website visitors during the use of the Website, its services, applications and products.

The use of the Website's services confirms the User's unconditional agreement with this Policy and the terms for processing User's personal data specified therein; in case of disagreement with these terms, the User should not use the services.

### 1. GENERAL TERMS

1.1. In the context of this Policy, the User's Personal Data is considered to be:

1.1.1. Personal Data that the User provides about himself/herself when using the Services (filling out feedback forms and summaries), including personal data of the User. Data required for the services is marked in a special way. The User at User's discretion provides other data.

1.1.2. Data that is automatically transmitted to the Website's services when they are used via software installed on the User's device, including IP address, cookie data, the User's browser data (or other application that accesses the services), technical characteristics of the hardware and software used by the User, date and time of access to the services, the addresses of the requested pages and other similar information.

1.1.3. Other User data the processing of which is provided for by the Agreement on the Website use.

1.1.4. This Privacy Policy applies only to the Website at the following address: [www.lhi.global](http://www.lhi.global). The Website does not control and is not responsible for third-party websites, links to which are available on the Website.

### 2. PURPOSES OF USERS' PERSONAL DATA PROCESSING

2.1. The Website collects and stores only the personal data required for the provision of services or the fulfillment of agreements and contracts with the User, except in cases where the legislation provides for the mandatory storage of personal data for a period specified by law.

2.2. The Website processes the User's personal data for the following purposes:

2.2.1. Setting up feedback with the User, including sending notifications and requests concerning the use of the Website, providing services, processing User's requests.

2.2.2. Determining the User's location to secure and prevent fraud.

2.2.3. Verification of the validity and fullness of the personal data provided by the User.

2.2.4. Providing the User with effective customer and technical support in case of problems related to the use of the Website.

2.2.5. Advertising activities with the consent of the User.

### 3. TERMS OF USERS' PERSONAL DATA PROCESSING AND ITS TRANSMISSION TO THIRD PARTIES

3.1. The Website should store Users' personal data in accordance with the internal regulations of certain services.

3.2. The confidentiality of the User's personal data should be maintained, except in cases when the User provides data about himself for public access to an unlimited number of people voluntarily. The User agrees that a certain part of his personal data becomes public in the process of using certain services by the User.

3.3. The Website has the right to transmit the User's personal data to third parties in the following cases:

3.3.1. The User has agreed in writing to such actions.

3.3.2. The transmission is required for the use of a certain service by the User or for the fulfillment a certain agreement or contract with the User.

3.3.4. The transmission is provided for by Russian or other applicable legislation in accordance with the procedure established by law

3.3.5. When the Website is sold, all obligations to comply with the terms of this Policy in relation to the personal data received by the acquirer should be passed to the acquirer.

3.4. The User's personal data may be processed without time limit in any lawful way, including in personal data information systems using and without automation tool. The personal data of Users should be processed in accordance with the Federal Law No. 152-FZ "On Personal Data" dated July 27, 2006.

3.5. The Website Administration should inform the User if personal data is lost or disclosed.

3.6. The Website Administration should take the required organizational and technical measures to protect the User's personal data against unauthorized or accidental access, destruction, modification, blocking, copying, disclosing, as well as against other illegal actions of third parties.

3.7. The Website Administration, together with the User, should take all required measures to prevent losses or other negative consequences caused by the loss or disclosure of the User's personal data.

### 4. OBLIGATIONS OF THE PARTIES

4.1. The user is obliged to:

4.1.1. Provide information about personal data required to use the Website.

4.2. The Website Administration is obliged to:

4.2.1. Use the data received exclusively for the purposes specified in this Privacy Policy.

4.2.2. To provide the storage of confidential data in confidence, not to disclose without the prior written permission of the User, as well as not to sell, exchange, publish or disclose in other possible ways the transferred personal data of the User, except as provided for in this Privacy Policy.

4.2.3. To take precautions to protect the confidentiality of the User's personal data in accordance with the procedure usually used to protect this kind of data in the current business environment.

4.2.4. To block personal data related to the relevant User at the moment of the request of User or his legal representative or the authorized body in charge of protecting the rights of personal data subjects for the period of verification in case of determining of false personal data or illegal actions.

## 5. RESPONSIBILITY OF THE PARTIES

5.1. The Website Administration has not fulfilled its obligations is responsible for losses of the User in relation to the misuse of personal data in accordance with the legislation of the Russian Federation.

5.2. In case of loss or disclosure of confidential data, the Website Administration is not responsible if this confidential data:

5.2.1. Became public before its loss or disclosure.

5.2.2. Was received from a third party before the Website Administration received it.

5.2.3. Was disclosed with the User's consent.

## 6. FINAL PROVISIONS

6.1. All relations relating to the processing of personal data that are not reflected in this Policy are regulated in accordance with the provisions of the legislation of the Russian Federation.

6.2. The operator has the right to make changes to this Policy. When changes are made to the current edition, the date of the last update is indicated. The new version of the Policy comes into force from the moment it is posted on the Site, unless otherwise provided by the new version of the Policy. ## 7. DISPUTE RESOLUTION

7.1. Before filing a claim in court regarding disputes arising from the relationship between the Site User and the Site Administration, it is mandatory to submit a claim (a written proposal for a voluntary settlement of the dispute).

7.2. The recipient of the claim, within 14 calendar days from the date of receipt of the claim, notifies the claimant in writing of the results of consideration of the claim.

7.3. If an agreement is not reached, the dispute will be referred to the court in accordance with the current legislation of the Russian Federation.

7.4. The applicable legislation of the Russian Federation applies to this Privacy Policy and the relations between the User and the Website Administration.

## 8. ADDITIONAL TERMS

8.1. The Site Administration has the right to make changes to this Privacy Policy without the User's consent.

8.2. The new Privacy Policy comes into force from the moment it is posted on the Site, unless otherwise provided by the new edition of the Privacy Policy.
